

AGREEMENT ON ACADEMIC COOPERATION
BETWEEN INSTITUTE OF ARCHITECTURE AND DESIGN
KYRGYZ STATE TECHNICAL UNIVERSITY, KYRGYZSTAN
AND SCHOOL OF ART AND DESIGN
SHAANXI UNIVERSITY OF SCIENCE AND TECHNOLOGY, CHINA

Institute Of Architecture And Design, Kyrgyz State Technical University, Bishkek, Kyrgyzstan and School Of Art And Design, Shaanxi University of Science and Technology, Xi'an, China, recognizing the benefits to their respective universities from the establishment of international links, conclude this Agreement.

- 1 The purpose of this Agreement is to develop academic and educational cooperation and to promote mutual understanding between the two Colleges.
- 2 Both Colleges agree to develop the following collaborative activities in academic areas of mutual interest, on a basis of equality and reciprocity.
 - (1) Exchange of faculty, researchers and other research and administrative staff
 - (2) Exchange of students
 - (3) Conducting collaborative research projects
 - (4) Conducting lectures and organizing symposium
 - (5) Exchange of academic information and materials
 - (6) Promoting other academic cooperation as mutually agreed
- 3 The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties, schools or institutes, which carry out the specific projects. Both Colleges agree to carry out these activities in accordance with the laws and regulations of the respective countries after full consultation and approval.
- 4 It is understood that the implementation of any of the types of cooperation stated in clause 2 may be restricted depending upon the availability of resources and financial support at the Colleges concerned.
- 5 Should any collaborative research activities under this Agreement result in any potential for intellectual property, both Colleges shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
- 6 This Agreement may be amended or modified by a written agreement signed by the representatives of both Colleges.
- 7 In the event of any unforeseen incident during collaborative activities in either country, both Colleges agree to negotiate a mutually acceptable solution.
- 8 This Agreement is valid for a period of five years from the date of signing by the representatives of both Colleges. This Agreement shall be renewed after being reviewed and renegotiated by both Colleges.
- 9 This Agreement may, at any time during its period of validity, be terminated by one of the universities upon prior notice to the other in writing not later than six months before the termination date.
- 10 This Agreement shall be executed in Chinese, English, and Russian, the English version being the main source of reference.
