- Master's degree (second level). Duration of training: 2 years. The master's degree receiving requires passing the final state exam and defend a thesis work.
- Postgraduate studies (Candidate of Sciences degree equivalent to postgraduate studies, PhD (without habilitation)). The holder of a master's degree and a specialist

		with a higher education are eligible for postgraduate studies. Duration of training is 3 years. The training ends with the defense of a thesis work, after the award of the scientific degree of candidate of sciences (doctor of philosophy) without receiving an education.  • Doctorate (doctoral degree, with certification). Duration of training is 3 years. Candidates of science with practical work experience are eligible to enroll in doctoral studies. The training ends with the defense of a thesis work, with the award of a doctoral degree (with habilitation).
8.3	Licensing and certification the educational professional programs	Higher educational institutions must have a license from the Ministry of Education and Science of the Kyrgyz Republic entitled them to carry out educational activities in order to implement educational programs of higher professional education at different levels. Every five years, higher education institutions must undergo accreditation by an independent accreditation agency.
